MCWEND settled last but one early, began to advance five wide through the far turn taking the lead at the three-sixteenths, edged clear in mid-stretch, just held on the bob from HENNESSY EXPRESS, who was caught three wide through the first turn, shifted in to the rail heading up the backstretch and advanced inside rivals, had nowhere to go boxed in on the rail inside and behind a rival nearing the three-eighths pole and was shuffled back, came out three wide leaving the far turn under urging, shifted in a bit in upper stretch, split foes near the sixteenth and once clear quickened late to just miss. MCGLORIOUS settled outside three to four wide through the first turn, advanced outside foes four wide on the far turn, came in a bit in the stretch and steadied to avoid an inside rival and was not given much effort in the final twenty yards but held show from BOBBIES FLIGHT, who was unhurried early racing well off the rest, fanned five to six wide into the stretch still last and rallied strongly late. WEDDING DANCE forced four wide in the early going, edged closer into the far turn to make a bid three wide leaving that bend and loomed a threat, evened out in the stretch. I'M A DANCIN WHO was keen to go on with it and edged clear leaving the first turn and entering the backstretch to dictate terms up the straight, challenged by outside rivals on the far turn while riding the rail, kept on till late before yielding. PINK CADILLAC was within range into the far turn tracking behind and off the fence, offered no late response. MOVIN ON led the field into the first turn then allowed a rival to go on with it and switched outside that one, pursued him from between foes into the far turn, came up empty.
