IMA HAPPY CAT broke out, sprinted clear at once, raced three-wide while setting the pace, drifted out slightly in mid-stretch and held sway to the wire. BELLA MIA tracked the pace of the winner from the inside, angled out into the stretch, drifted out to bump rival nearing the sixteenth pole, angled in and finished with good courage. DONTKISSNTELL settled off the leaders early, advanced five-wide through the turn, was bumped nearing the sixteenth pole and continued on to finished with good energy. PADDY'S SECRET showed no early speed, raced off the rail through the turn and finished with a late rally. BEST OF ME chased the winner while racing four-wide, was bumped and checked nearing the sixteenth pole and lost chance. ALWAYS ENUFF was off a step slow, settled off the leaders from the inside, angled out into the stretch and did not menace. NO TALKING BACK lacked early foot, raced six-wide through the turn and was not a factor. B C Z MIDDLETON lacked early speed, raced between foes through the back-stretch, moved four-wide through the turn and failed to offer a bid. DIAMONDS R was void of early speed, raced four-wide through the turn and did not reach contention. THE STEWARDS CONDUCTED AN INQUIRY CONCERNING THE DRIFTING OUT AND BUMPING OF BEST OF ME BY BELLA MIA NEARING THE SIXTEENTH POLE AND AFTER REVIEWING THE FILMS THE STEWARDS CONCLUDED THAT BELLA MIA HAD CAUSED THE INCIDENT AND WAS DISQUALIFIED FROM SECOND AND PLACED FIFTH.
