VOW ME NOW raced two wide in first turn then forwardly placed and rated off the top pair, patiently ridden along inside through far turn, angled out path entering top stretch, found path between, split foes gamely then surged forward, dueled for lead in final strides and denied rival by nose. ART G IS BACK rated off the early pace, advanced closer contention racing three to four wide in far turn, set down driving six path at furlong marker, dug in determinedly, briefly held slight edge then dueled in final strides and got nipped on wire. STIRLING DRIVE tracked the leader through backstretch, dueled for lead with HIGGINS through far turn, continued to battle back with added challengers a furlong out, could not kick on with top pair then just prevailed for show. TIMMY M. sat back off early pace, took closer order along outside late far turn, fanned out six to seven wide upper stretch, gained position then got nipped for show. BAD TO THE CORE (FR) unhurried through backstretch, lacked room racing two path late final turn, continued traffic top stretch then shifted out and improved position. SHARETHEBLAME settled off early pace, gained ground racing four wide through far turn, lacked path top stretch, shifted in two path then inside, had no room and forced to be taken up. HIGGINS set the pace to the far turn then dueled for the lead, continued to battle back a furlong out then gave way. SCRAPS raced near midpack, saved ground through backstretch, steadied near quarter pole, cut the corner went to make bid but cut off and forced to be taken up. SEA OF HOPE raced in range, hustled up in far turn then retreated past the quarter pole, pulled up after race, walked off, bled while racing. THE STEWARDS POSTED INQUIRY LOOKING INTO RUNNING OF .2 SCRAPS AND .4 SHARETHEBLAME IN STRETCH, AFTER REVIEW STEWARDS TOOK NO ACTION
