ROYAL SQUEEZE raced under a snug hold to track pace along inside then switched out a path and steadied at half mile marker, let out three furlongs from home, vied for lead with DRIVEN BY THUNDER then cut the corner and turned for home with advantage, widened on top then held firm under driving finish. GARTER AND TIE raced off the pace under steady urging, hustled up four wide through the turn then kept on with response along outside in stretch and produced solid finish. MR. JORDAN raced in the back along outside, picked up pace along outside in turn then set down driving racing five to six paths wide upper stretch and finished with response. DRIVEN BY THUNDER tracked early leader then dueled through turn, could not kick on with eventual winner top stretch but kept along in striking range then steadily weakened and lost show. HY RIVERSIDE raced off the pace, saved ground then hustled up along inside in turn, had to wait for position at quarter pole, shifted out wide losing ground entering top stretch then kept on with interest. KROY quickly cleared on top and angled in to match strides for lead, dueled outside path of SARASOTA COUNTY, edged by rival while taking on new set of challengers, could not keep pace and weakened. FRONT LOADED raced of the early pace, showed response racing two wide in the turn then faded in stretch. THREE RULES not far off front end in early stages then put to drive three wide in the turn, failed to kick on then faded in stretch. SARASOTA COUNTY dueled for the early lead then retreated in the turn.
