

6 FURLONGS. (1072) SAGAMORE SAIRED S. Purse \$100,000 (includes \$65,000 ITDF - Indiana TB Development Fund) FOR REGISTERED INDIANA SAIRED, THREE YEAR OLDS. By subscription of \$100 each which shall accompany the nomination, \$200 to pass the entry box and an additional \$100 to start, with \$100,000 added. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$850 which includes entry and starting fees. After paying 1% to all owners of horses finishing sixth through last, the purse will be divided, 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of \$45,000 allowed 2 lbs; of \$21,000, 4 lbs, of a race other than maiden or claiming allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. Trophy to the winning owner. NOTE: This racee will be limited to 12 starters. If more than 12 horses pass the entry box preference will be given to those with the highest weights.
