EDGE OF PLEASURE sprinted to a clear lead soon after the start, set the pace along the rail for a half, had speed until mid stretch then weakened. GRIZABELLA failed to menace. MOBIL LADY had speed for a half then faded. BLANCONIA was unprepared for the start, broke in a tangle causing her rider to lose his right iron and was declared a non starter by the stewards. TURNDOWN DA VOLUME was through after a half. THE STEWARDS POSTED THE INQUIRY SIGN AND AFTER REVIEW DETERMINED THAT BLANCONIA DID NOT RECEIVE A FAIR START THEREFORE WAS DECLARED A NON STARTER
