GRINNING TIGER had speed outside a rival then inched away and angled in, set the pace along the inside, came a bit off the rail into the stretch, drifted in a bit in deep stretch and held on gamely under urging. LIEUTENANT DAN three wide into the first turn, stalked outside a rival, came three deep into the stretch, drifted in a bit in midstretch and edged a rival for the place. BRANDOTHEBARTENDER angled in and saved ground stalking the pace, came out into the stretch and was edged for second. KING ABNER between horses early, angled in on the first turn and saved ground stalking the pace, continued inside in the drive and lacked the needed rally. WARD 'N JERRY settled three deep then a bit off the rail chasing the pace, angled to the inside on the second turn, came out in midstretch and could not summon the necessary late kick. CONO pulled along the inside then came out approaching the first turn, stalked just off the rail to the stretch, was between horses in midstretch and weakened late. PRINCE EARL a half step slow to begin, chased between horses then outside a rival on the second turn, came three wide into the stretch and did not rally. OLIVER chased three deep, dropped back outside a rival on the second turn, angled in a bit and gave way.
