ESSENTIAL QUALITY broke outwards and bumped a foe at the start, raced off of the pace two wide around the first turn, tipped outside of foes into the backstretch, advanced four wide around the far turn to take aim on the leaders in upper stretch, switched leads approaching the furlong pole, produced a good kick, and edged past the leader in the late stages. HOT ROD CHARLIE tracked from midpack three wide, commenced a rally approaching the half mile pole, sustained that gain around the far turn to bid for the lead outside of JACKIE'S WARRIOR turning for home, forged a narrow advantage from that one passing the furlong pole, but got run down by ESSENTIAL QUALITY passing the sixteenth pole. KEEPMEINMIND received a solid bump from an inner foe at the start, trailed the field around the first turn, rallied stoutly around the far turn while tipping to the four path, then sustained that rally to achieve show in the final sixteenth while gaining on the leaders. JACKIE'S WARRIOR stalked along the inside around the first turn, tipped three wide into the backstretch to be outside of rivals, inched forward down the backstretch to vie outside of DREAMER'S DISEASE around the far turn, forged an advantage from that foe turning for home while HOT ROD CHARLIE ranged up along side, clung to a lead from that foe in upper stretch, but was headed by that foe passing the furlong pole, and yielded. ROMBAUER raced far off of the pace two wide, took the far turn in the three to five path, and stayed on to improve position. DREAMER'S DISEASE broke sharply and set a pressured pace along the inside, but was headed by his pressing counterpart turning for home, and weakened in upper stretch. KING FURY tracked from midpack along the inside, but was shuffled back behind a tiring foe around the far turn, tipped two wide in upper stretch, and chased without menacing. CLASSIER prompted the pace two wide and between horses around the first turn, took back to stalk into the backstretch, but failed to keep pace with the leaders into the far turn, and faded thereafter. SITTING ON GO raced far off of the pace in the two path around the first turn, then was caught five to six wide and outside of foes around the far turn, and failed to factor. REINVESTMENT RISK saved ground off of the pace around the first turn, then tracked two to three wide and between horses around the far turn, but failed to produce a bid. CALIBRATE got caught four wide around both turns while off of the pace, and never got involved. CAMP HOPE broke inwards, then saved ground far off of the pace, but to no avail. LIKEABLE pressed the pace three to two wide into the backstretch, but weakened into the far turn. NEXT chased the pace four wide around the first turn, but failed to keep pace with the leaders into the backstretch, was done early, wilted around the far turn, and was eased through the lane.
