COASTAL MISSION stalked the early pace from the three path, took the nod past the half mile pole and pulled himself clear at the five sixteenths, raced at the rail on the far turn and held on under steady stretch handling. NO CHANGE raced well back saving ground on the first turn, improved leaving the turn and raced at the rail on the far turn, came between horses past the eighth pole then dueled through the final sixteenth for second. SOCIAL CHIC saved early ground, bid leaving the seven sixteenths pole, raced in the four and five paths of the far turn then outfinished for second the final sixteenth. FREE SAIL IN rated as lime early lead inside, was met leaving the first turn and stayed close past the half mile pole, challenged from the three eighths but dropped back at the five sixteenths and flattened through later yards. MUAD'DIB raced with the pace through the front stretch then eased out and stalked into the first turn, picked up the chase from the seven sixteenths pole, raced close in the three path of the far turn but flattened through later yards. LATE IN THE GAME saved ground on the first turn, started a bid nearing the three eighths pole and raced at the rail on the far turn, eased out ward through the upper stretch and passed some rivals outside. JUNGLE BEAST settled off the rail on the first turn, eased out leaving the turn and gave chase from the three eighths pole, raced in the four path of the far turn then flattened stride. NICO rounded the first turn about the three path, gave chase from the three eighths pole but flattened in the five path of the far turn. CANDY INVASION broke a step slow and never factored. ROYAL PAIN rated close inside on the first turn and showed little response through the backstretch.
