**7 FURLONGS. ( 120 ) SIR SHACKLETON S.** Purse \$100,000 ( plus\$45,000 FTBOA – FL TB Owner Brdr Assoc Fund ) **FOUR YEAR OLDS AND UPWARD.** Free nomination by Saturday, March 18. \$1,000 to enter. \$100,000 Guaranteed. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(Not part of the announced gross purse, The FTBOA offers \$25,000 to the owner of a registered Florida-bred finishing first plus \$5,000 to owners of a registered Florida-bred finishing second through fifth, paid directly by the FTBOA). Weight: 124 lbs. Non-winners of a graded stakes since September 1 allowed 2 lbs.; a stakes race since June 1, 4 lbs.; three races other than maiden, claiming, starter or state-bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners 2021-23, graded stakes-placed 2021-23, non-restricted stakes winners 2022-23, then by highest career earnings. Trophy to the winning owner.

WEYBURN bumped with an inner foe at the start, tracked in the six path, was roused to range up in the five path around the turn and bid into the stretch, took a narrow lead and was cued right handed passing the eighth pole, tipped inwards to meet the challenge of an inner rival, brushed with that inner rival passing the sixteenth pole, and held on. DEAN DELIVERS settled in range around the three path, was coaxed passing the three eighths pole and urged right handed from the two path into the stretch, ran on and bid entering the final furlong, dueled with an outer foe to the wire and brushed with that foe passing the sixteenth pole and was denied to finish with place honors. STEAL SUNSHINE trailed in the four path and was roused into the turn, fanned out to the eight path under right handed urging into the stretch, and rallied down the center for show. CELESTIAL GLAZE rated in the seven path, was driven in the five path around the turn and swung back out to the seven path into the stretch, and finished evenly. COLLABORATE stalked in the five path, was ridden in the four path around the turn, got stymied briefly passing the quarter pole and shifted into the three path into the lane, but flattened out. OCTANE bumped with an outer foe at the start, prompted the pace in the four path, was coaxed to bid early around the turn, but faded from the five path in the stretch. MISH set the pace in the three path, was roused in the two path midway around the turn, floated out to the four path into the lane, and yielded in the final furlong. PACO'S PICO pressed in the two path but gave away along the inside turning into the lane. MY PRANKSTER chased in the four path but was no menace.
