MO STASH set the pace along the inside, shook free of a pressing foe entering the lane, met NAGIRROC's bid approaching midstretch, and held firm through the final furlong, NAGIRROC tracked three wide, took aim on the newly clear leader in upper stretch, attempted a bid in midstretch, but was turned away. WEBSLINGER settled far back along the inside, bided time outside of foes while caught in the four to five paths around the far turn, then rallied willingly outside of foes through the lane. MI HERMAN O RAMON checked while forward behind the top pair into the first turn, stalked from the two path, but lacked a bid while only able to chase through the lane. ANDTHEWINNERIS raced far back three wide, turned for home in the four path and between horses, but was steadied once put to crowded quarters among horses in upper stretch, altered course outwardly, and recovered to rally for a minor share. CANDIDATE broke awkwardly before shying from an inner rival at the start, pursued from midpack two wide under snug restraint around the first turn, inched closer four wide around the far turn, but was bumped by an inner rival while between horses in upper stretch, and leveled off. FREEDOM TRAIL saved ground off of the pace, shifted out and caused trouble for a group of outer rivals in upper stretch, then lacked a rail charge thereafter. DUDE N COLORADO (GB) stalked outside of the leader, but gave way entering the lane, and weakened between horses. WONDERFUL JUSTICE (GB) checked into the first turn before settling into an inside tracking position, pursued from the two path around the far turn, but was bumped by an inner rival and putto crowded quarters between horses in upper stretch. MOVISITOR broke a steps low, laid off of the pace two wide, then in the three path between horses around the far turn, but was bumped by an inner rival into an outer foe in upper stretch, and made little impact. RARIFIED FLAIR was outrun.
