FIRST PEACE shifted in to bump early, chased from inside into the turn, waited behind the top pair at the quarter pole, cut the corner into the lane, slipped through inside HELL ADIC to take over in upper stretch and maintaine da clear lead over MAS RAPIDO (GB) in the final sixteenth. MAS RAPIDO (GB) got bumped by FIRST PEACE then unhurried in the early going, raced along the rail then angled out across the dirt, rallied in the lane but was outkicked by the winner. VALIAN CER trailed along the inside into the turn, saved ground then moved off the rail across the dirt, angled out further in the lane and bested the rest. CON CL UDE came out and bumped rival early, tracked two to three wide on the turn, bid outside the top pair and four wide into the stretch but was no match in the final furlong. HELLADIC broke out and bumped rival then sped clear, held a short lead over NULL ARBOR around the turn and into the stretch, was overtaken by the winner in upper stretch and weakened in the late stages. FLEET FEET raced near the back four wide into the turn, angled to the two path around the bend, steered out back out and lacked a rally. NULLARBOR got bumped on both sides leaving the gate, was closest in pursuit early, bid two wide around the bend, fought to upper stretch and faded. MARKS HIP took a bump from inside leaving the gate, got impeded and bumped by CONCLUDE early, checked between rivals shortly after, became rank nearing the turn, went two to three wide around the bend, moved out across the dirt and had little left for the drive. THERE WAS ASTEWARDS' INQUIRY INVOLVING THE INCIDENT BETWEEN CONCLUDE AND MARKS HIP EARLY IN THE RACE AND RULED THAT ALTHOUGH CONCLUDE DID CROSS OVER ON MARKS HIP, THAT RIVAL WAS NOT COST A CHANCE AT A BETTER PLACING AND NO CHANGE WOULD BE MADE.
