Non-winners of \$15,000 twice at one mile or over since October 23 allowed 4 lbs. such a race since then 2 lbs. Failure to draw into the race will cancel all fees. (Rail set at 21 feet).

MARICOPA COUNTY was unhurried early and trailed the field, went widest in the drive and finished well. ARIZONA JEREMY raced close to the pace, bid and came up empty. MOONLITE GRAHAM set the pace to the second turn, tired and gave way. Hand timed.
