PRETTY LIAM was reluctant to load, lugged in midway down the backstretch, saved ground off the pace around the turn, angled four wide in upper stretch and gained the show while lugging in through the lane. TIGER BELLE (IRE) stalked the pace inside, continued on the left lead in the lane and weakened. LET THEM WAT CH steadied early, raced four wide and never threatened. DOT steadied early, raced three wide and made little impact. EL TERRENO dueled inside of the winner to upper stretch, stopped and was eased.
