JOHNNY PODRES settled off the pace, rounded the bend two then three wide, gotfloated out across the dirt, rallied widest in the stretch and edged LOVESICK BLUES in the end. LOVESICK BLUES showed early speed between rivals then ceded command and stalked two wide into the turn, moved out and came four wide into the stretch, launched a bid outside the top pair approaching the eighth pole, battled through the final furlong and got outgamed by the winner. CLOVISCONNECTION set the pace outside a trio of rivals early then cleared and angled in entering the turn, confronted by CATALINA EDDY entering the stretch, dueled and resisted to the sixteenth pole, then yielded late and managed to save third. CATALINA EDDY showed early speed between rivals then took back to stalk the leader, went three wide into the turn, moved into the two path around the bend, challenged from outside entering the lane, dueled to sixteenth pole and never found the needed late kick. COALINGA ROAD trailed on the inside into the turn, shifted to the two path around the bend, angled out crossing the dirt, boxed in upper stretch, moved out a bit and kept trying to the wire. NONE ABOVE THE LAW broke a bit slow, chased along the rail then two wide, roused in upper stretch and could not rally. DISKO TRIBUTE pressed early inside rivals then was rated on the inside, saved ground through the turn, roused leaving the dirt and tried to launch a bid inside the leader but lacked room at the top of the lane, then weakened in the final furlong.
