SAMBAS MARK pressed the early pace, raced three wide and weakened late. DEL BERT TOO was taken back early, raced eight wide out of the turn, angled in and finished belatedly. TUCUM was allowed to settle from between rivals and faded. MCMERCEL US was reserved early from between rivals and flattened out. IZERIGHT was unhurried early, raced eight wide and offered no late rally. ROLL PENNY ROLL was up close early from the inside and faded. STRAW BERRY WHISKY was void of any early speed, raced seven wide and was no factor. MONARCHOS DREAM was not far back early from off the rail and was finished early.
