1/8 MILES. ( Turf ) ( 1.443 ) DEL MAR DERBY Grade II. Purse \$200,000 ( plus \$3,000 Other Sources ) FOR THREE-YEAR-OLDS. By subscription of \$200 each, which shall accompany the nomination, Closed August 27, 2020 with 20 or by supplementary 1 nomination of \$2,000 each by closing time of entries, and \$3,000 additional to start, with \$200,000 Guaranteed, of which \$120,000 to first, \$40,000 to second, \$24,000 to third, \$12,000 to fourth and \$4,000 to fifth. Weight 122 lbs. First preference will be given to graded or group stakes winners. Second preference will be given to horses which have finished second or third in a Gr. I or Gr. II stakes. Total non-claiming purse earnings in 2020 will determine the order of preference for horses of equal status. STARTERS TO BE NAMED THROUGH THE ENTRY BOX BY THE CLOSING TIME OF ENTRIES, THURSDAY, SEPTEMBER 3. A trophy will be presented to the winning owner.

PIXELATE bumped twice leaving the gate, tracked from the inside then angled out on the far turn, closed in the lane and surged late to get up in time. MARGOT'S BOY stalked a bit off the rail, took aim two wide into the stretch, bid outside and forged to the front at the sixteenth pole then nailed by the winner. DOMINANT SOUL showed the way early, set the pace up the backstretch, saved ground while clear into the stretch and yielded late. CALIFORNIA KOOK placed off the pace and a bit off the rail, went between foes into the far turn, lacked room and steadied at the five-sixteenth pole, asked to go through rivals again into the stretch and finished willingly for a minor award. KISS TODAY GOODBYE unhurried and settled outside a rival, angled four wide around the second turn and summoned a mild late bid. KANDEREL settled off the pace, raced in a bit tight into the stretch, lost the whip and brushed with rival in upper stretch and gained ground late. AMERICAN FARMER tucked inside and saved ground to the stretch and went evenly late. K P ALL SYSTEMS GO unhurried from the start and angled to the inside, saved ground into the stretch, brushed with rival and failed to threaten. GUITTY (FR) off slow at the start, traveled near the back of the pack, went between foes into the far turn, lacked room and checked past the five-sixteenth pole, came out into the lane then altered out further behind a pair of rivals and could not rally. HEYWOODS BEACH off the rail throughout, came four wide into the stretch and made no impact. NO SLO MO bumped twice at the start, chased off the rail, three wide into the stretch and weakened. HAND TIMED.
