MIZZEN BEAU broke inward, showed speed and set a reserved pace, quickened on the turn then widened in the stretch and finished under a hand ride. AFL EET KATHERINE hopped leaving the gate, settled in mid pack, was hustled from the rail and two-wide on the turn then finished gamely. TRUTH HURTS stalked the pace, was hustled along the rail through the turn and completed the course under a determined drive. GUN SOCIETY raced from off the pace, closed three and four-wide on the turn, chased into the stretch and rallied outside. PSEUDONYM settled off the pace, closed five then four-wide through the turn, chased into the stretch and evened out in the late stages. INFINITE PATIENCE showed brief speed then forced the pace, raced three and four-wide on the turn, chased into the stretch but backed away in the final furlong. JUSTLEAVEIT ALONE settled in mid pack, was hustled four-wide on the turn then flattened out in the stretch. BALLROOMS OF MARS, in range, dropped back late turn and lacked a closing response.
