FAST BOAT rated far off of the pace along the inside, swung five wide turning for home, rallied outside of SOMBEYAY to bid for the lead passing the furlong pole along with that rival, bumped with that foe in the process before dueling with him through the final furlong, and prevailed. SOMBEYAY advanced three wide and outside of rivals from far off of the pace down the backstretch, shifted four wide entering the lane, sustained his charge through upper stretch to bid for the lead between horses at the furlong pole, but was jostled between those rivals passing that marker, continued the duel thereafter, but was bested by his outer foe in the final sixteenth. CLASSY JOHN stalked along the inside, shifted three wide in upper stretch, rallied to produce a bid approaching the furlong pole as a pair of outer foes did the same, drifted out and bumped a rival passing that marker, shifted back inwards in the aftermath, and got outkicked. DIAMOND OOPS lied off of the pace two wide, but steadied in a bit of tight quarters approaching the five sixteenths pole, shifted inside of rivals in upper stretch, and sustained a rail gain for a minor share. CAROTARI tracked from midpack in the three path, got briefly blocked in tight quarters in upper stretch, but sustained an advance through traffic before being herded outwards at the furlong pole, and stayed on late. JOHNNY UNLEASHED saved ground from midpack, chased from behind the leading group in upper stretch, came outwards passing the furlong pole, but failed to challenge between horses late. SMART REMARK was allowed to settle, circled into the stretch five wide and improved position. JUST MIGHT disputed the pace to the outside of FLYA to the final furlong and succumbed. GUILDSMAN (FR) was slow into stride, settled along the hedge, shifted out in upper stretch and passed some tiring ones. AMBASSADOR LUNA was allowed to settle three deep, came four wide into the stretch, but came up empty entering the stretch and faded. FIYA contested the pace along the shrub to the furlong marker and faded fast, then was vanned off.
