7 FURLONGS. (1.20²) EIGHT BELLES S. PRESENTED BY SYSCO Grade II. Purse \$600,000 (includes \$100,000 KTDF - Kentucky TB Devt Fund) FOR FILLIES, THREE YEARS OLD. By subscription of \$300 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry. \$2,500 to pass the entry box; \$2,500 additional to start, with \$500,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a Grade I stakes, allowed 2 lbs.; a Grade II or III stakes, 4 lbs. The maximum number of starters for the Eight Belles will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners (in order I-II-III), then highest career earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Wednesday, April 10, 2024 with 43 nominations.

MY MANE SQUEEZE settled in hand, ranged up four wide through the turn, came to level terms entering the stretch, shook clear and held sway. IMPEL attended the pace off of the inside, took closer order through the turn, angled out with a furlong to run, kicked on well but was unable to bridge the gap. ASTERNIA opened clear to dictate terms towards the inside, was collared leaving the turn and gave way once headed. HALINA'S FORTE tracked three deep, bid between rivals leaving the turn, but flattened in the drive. DO GOODER was fractious in the gate, came away a beat slow, moved up five wide through the turn, offered a mild bid but failed to sustain the drive. LADY MOSCATO was unhurried off of the inside, finished with a belated improvement, but failed to threaten. DENIM AND PEARLS settled between horses, was put in tight when ALL THINGS GO moved up between foes, brushed with that one slightly, recovered quickly and advanced through the turn, but came up empty entering the stretch and failed to threaten. ACCOMMODATE EVA saved ground to little avail. TANYA SHOWERS was allowed to settle, came under a ride midway through the turn, wheeled out eight wide but lacked the needed response. ALL THINGS GO was unhurried into stride, moved up entering the turn, was caught in tight and brushed with DENIM AND PEARLS near the seven-sixteenths pole, lost position and showed little thereafter. R HARPER ROSE was close up three wide for a half and dropped out.
