( Turf ) ( .533 ) GULFSTREAM PARK TURF SPRINT S.** Purse \$165,000 ( includes \$15,000 FTBOA – FL TB Owner Brdr Assoc Fund ) **FOUR YEAR OLDS AND UPWARD.** Free nomination by Sunday, January 12. \$1,500 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight: 124 lbs. Non-winners of a graded stakes since July 1 allowed 2 lbs.; Graded stakes placed since then or non-winners of an unrestricted stakes race since April 1, 4 lbs.; three races other than maiden, claiming, starter or state bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2023–25, then graded stakes placed in 2023–25, then stakes placed in 2024–25, then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 66 feet).

COPPOLA set a clear pace along the the rail and held safe under a drive. CAPTURE THE LION raced off the pace three wide, rallied between foes and gained the place late. REEF RUNNER bumped at the start, raced off the pace three wide, angled six wide in upper stretch, continued on the left lead and rallied for the show. THAT'S RIGHT bumped at the start, raced two wide in mid pack, angled five wide in upper stretch and rallied belatedly. JOHNNY PODRES saved ground off the pace and rallied belatedly at the rail. MUCHO DEL ORO bumped at the start, saved ground well back, tipped two wide in upper stretch and ran on. NOBALS bumped at the start, raced two wide and never threatened. YES I AM FREE chased the winner two wide in the clear and faded through the final furlong. PORTOFINO bumped at the start, raced three wide and never factored. AXTHELM was unprepared for the start, trailed inside and never reached contention. PANTHER ISLAND chased the pace inside and lacked a closing bid. SMITHWICK'S SPICE bumped at the start, chased the pace two wide and lacked a rally.
