UNCLE CURLY eyed the battling leaders going to the far turn, ranged up three wide to challenge past the quarter-pole, lugged in through upper stretch in front of GOOD SOLUTION, continued to lug in tightening things up on MR STARK, then swerved out sharply and continued erratically to the wire. MR STARK argued the pace inside GOOD SOLUTION from the start, battled back to get the lead after being headed by the latter late on the far turn, steadied along the rail in midstretch and was coming back on UNCLE CURLY in the closing yards. GOOD SOLUTION contested the pace outside MR STARK to the top of the lane, checked when UNCLE CURLY came over in front of him in upper stretch, and saved the show while weakening. KING OF LEINSTER (IRE) raced three to four wide on the turns, and rallied mildly on the far outside for a share. GOLDENLINE OF saved ground throughout, and lacked a solid bid. WOLF RIDGE was reserved early three wide, and lacked the needed response when roused. LONDON WEREWOLF was no factor through an inside journey. Run-up unavailable. FOLLOWING A STEWARDS INQUIRY AND CLAIMS OF FOUL BY THE RIDERS OF MR STARK AND GOOD SOLUTION AGAINST UNCLE CURLY, THE LATTER WAS DISQUALIFIED FROM FIRST AND PLACED THIRD FOR CAUSING INTERFERENCE IN THE STRETCH.
