GOLDEN MISCHIEF chased the pace early, fanned into the five path in the turn, was under a long drive in the stretch, drifted out late and prevailed in the final stages. CHALON tracked the pace, swung into the six path in the turn, made a bid and was under a long drive in the stretch three wide but did not have enough in the final stages. VERTICAL OAK set the pace early, shifted into the four path in the turn, was under a long drive from between horses, steadied late and yielded in the final stages. MISS SUNSET stalked the pace early, shifted into the three path in the turn, made a bid down the lane but hung in the late stages. HAPPY LIKE A FOOL pressed the pace early, fanned into the five path in the turn and flattened out late in the stretch run. AWESTRUCK back early on, was bumped and bothered nearing the seven sixteenth pole, was on the inside into the lane and leveled off late in the drive. RICH MOMMY raced back early on, was on the inside into the lane and moved up in the stretch drive. CURLIN'S APPROVAL bumped foe nearing the seven sixteenth pole. TORRENT shifted into the three path in the turn and lacked a rally down the lane. CRAZY SWEET was through after a half. THE RIDER OF VERTICAL OAK CLAIMED AN OBJECTION AGAINST THE RIDER OF GOLDEN MISCHIEF FOR INTERFERENCE IN THE LATE STRETCH BUT AFTER REVIEW BY THE STEWARDS THE CLAIM WAS DISALLOWED.
