1 MILE. (Inner Turf) (1.32) JUST A GAME S. Grade I. Purse \$500,000 INNER TURF FOR FILLIES AND MARES, FOUR YEAR OLDS AND UPWARD. Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$500 each which should accompany the nomination. \$3,500 to pass the entry box and an additional \$4,000 to start. A supplemental nomination fee of \$2,500 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The purse will be divided accordingly, \$275,000 to the winner, \$100,000 to second, \$60,000 to third, \$30,000 to fourth, \$20,000 to fifth and \$15,000 divided equally amongst the remaining finishers. Weights 124 lbs. Non-winners of a Grade/Group I race at a mile or over in 2023-24 allowed 2 lbs.; of a Grade/Group II race at a mile or over in 2023-24 allowed 4 lbs.; of a Grade/Group III race at a mile or over in 2023-24 allowed 6 lbs. Trophies will be presented to the winning owner, trainer and jockey. The New York Racing Association reserves the right to transfer this race to the Main Track. In the event that this race is taken off the turf, it may be subject to downgrading upon review by the Graded Stakes Committee. Closed Saturday, May 25, 2024 with 20 Nominations. (Rail at 18 feet).

CHILI FLAG (FR) moved in early, went around the first turn in the two path, was unhurried at the back, shifted from the rail to the two path on the far turn, nudged MISSION OF JOY out while swinging five wide into upper stretch, rallied outside coming to the furlong marker and closed strongly to get up in the final sixteenth and prevail. WHITEBEAM (GB) established forward position early, raced in the three path on the first turn, prompted the pace on the outside, vied in the two path on the far turn, was asked near the quarter-pole then took a short lead in upper stretch, led under a drive into the final sixteenth but was denied while just able to get the place. MISSION OF JOY rounded the first turn in the two path, settled off the pace, was urged along late on the backstretch, went three wide on the far turn, was nudged out to the six path by the winner into upper stretch, rallied outside into the final furlong and closed well to just miss the place. EVVIE JETS went to the front, dropped in entering the first turn, showed the way on the inside with some company to her outside, was asked near the quarter-pole then lost the advantage in upper stretch, fought on well to the finish and just missed the trifecta. GINA ROMANTICA traveled around the first turn in the two path, settled off the pace, was asked in the three path on the far turn, chased the leader in the stretch and was out-kicked. COPPICE (GB) hit the outside of the gate and was last to commence, saved ground on the first turn, was reserved off the pace, raced in the two path while let out on the far turn, was roused into upper stretch, chased while remaining on her inside lead into the final furlong, pursued the vanguard to the finish and was also out-kicked. BEAUTE CACHEE (FR) was taken in hand early, tossed her head while checking along the rail late on the first turn, was rated just off the pace on the inside, came under encouragement while saving ground on the far turn, turned into upper stretch under a drive and weakened. FOLLOWING THE RACE, THE RIDER OF MISSION OF JOY CLAIMED FOUL AGAINST THE WINNER ALLEGING INTERFERENCE AT THE TOP OF THE STRETCH. AFTER THE STEWARDS' REVIEW, NO CHANGE WAS MADE TO THE ORDER OF FINISH
