FORTUNA MIA laid off of the pace along the inside, pursued from the two path ar ound the turn, was roused outside of the leading trio turning for home, claimed show enter ing the lane, then lev eled off whliehanging on her left lead. GLEE broke in while off slow, lacked speed in the three to two path, then moved up between horsestoreachfourth at the wire. ADEERA broke a step slow, tracked in the thr ee path before tucking to the inside pursuing into the turn, chase d through upper stretch and gave way. DAISYDUKE trailed in the thr ee to four path before moving to the six path into upper str etch, but failed to factor. LA MARINERA chased forwardly in the four to three path, lost show to a n outerbidder entering the lane and weakened betwe en horses whlie hanging on her left lead.
