FANDOM (GB) brushed with an outer rival at the start, backed off to track threewide, shifted out to the six to seven path in upper stretch, rallied to bid outside of the leaders at the sixteenth pole and edged past. MANSA MUSA (IRE) broke slowly, tracked along the inside, progressed to bid inside of the leaders in the final furlong, vied in the final sixteenth but was outfinished by an outer bidder. REFUEL prompted three deep, spun for home in the five path, dueled with inner rivals through midstretch, but was outkicked by bidders on either side entering the final sixteenth, kept on and prevailed for show. NO NAY METS (IRE) led inside of a pair of vying rivals, dueled with them shifting to the two to three path in upper stretch, fought on in the final furlong, but was headed between bidders at the sixteenth pole and yielded. MATTINGLY stalked along the inside, shifted out to the six path in upper stretch, chased but lacked a bid. SILENT HEART vied for the lead two wide and between horses, spun into the lane in the four path, sustained the battle between foes into the final furlong but faded at the sixteenth pole. SHARDS raced towards the rear two wide, shifted out leaving the furlong ground, came nine wide at the sixteenth pole and ran on mildly. MY BOY PRINCE pursued two wide and between horses, shifted eight wide in upper stretch and failed to factor. ASPENITE lacked speed two wide, drifted out in midstretch and made little impact. COIN MINER broke slowly, trailed along the inside and failed to factor between horses. CEEPEEGEE brushed with an inner foe at the start, saved ground off of the pace but to no avail. COMMITTEE OF ONE laid off of the pace four wide, swung to the nine path in upper stretch and faded.
